## 5. TERMS AND CONDITIONS

1. To become a carer it is essential that you become a member of the V.H.S. and remain a member for the time you have a V.H.S. registered horse or pony.
2. Once registered as a carer, your name will remain on our register until (a) we find a suitable a suitable veteran for you to re-home, or (b) you notify us in writing that you wish to be removed from the register.
3. The registration fee is non-refundable under any circumstances.
4. The V.H.S. only acts as an introducer between carer and owner. It is the responsibility of the carer to ensure that the potential equine is suitable for your needs.
5. The V.H.S. will not knowingly introduce the owner to unsuitable carers. The V.H.S. can not however be held responsible for any incompatibility between carer and owner or equine, nor shall be responsible for any costs in rectifying any problems.
6. The V.H.S. recommends that you have legal counsel draw up a "Loan Contract", to protect ownership of the horse or pony, and define your limitations as a carer.
7. The V.H.S., or one of its representatives, may from time to time perform spot checks on the re-homed horse or pony. Should any of these checks reveal a concern regarding the welfare of the animal, you agree to the V.H.S. contacting your vet to discuss the concerns, where this could prove in the best interests of the animals welfare.
8. You agree to ensure that the V.H.S. is notified of any changes in the livery location of the animal, after re-homing is complete, and agree to the V.H.S. or its representatives having access for random spot checks as detailed in 7 above. The V.H.S. is only concerned for the welfare of the animal at all times.
9. The society would like to point out that the home offered to a veteran must be for life. Only in exceptional circumstances can the society intervene between carer and the owner.
10. Each carer must be registered with a Vet Practice, EDT Equine Dentist and Registered Farrier before the application can be accepted. Please provide proof of this with your application.

## 5. DECLARATION
